Westmont Street Fair Display & Demo - General Information

Location: The event is being held in the Manning Parking Lot, 221 N. Cass Ave. Cass Ave. is located 1 ½ miles west of Route 83. The lot is 2 ¼ blocks north of the BNSF tracks.

Note: *Cass Ave. will be closed to vehicular traffic from Naperville Rd on the north to the BNSF tracks on the south from 4:30pm until 9pm.*

Directions: From the north take Ogden Ave (Rte. 34). Go south on Cass. From the south take 55th Street. Go north on Cass. Prior to 4:30, participants may proceed directly to lot; drop off your aircraft/equipment. If available, park in rear of lot by school. After 4:30pm, from either direction, turn at the barricades to the first side street east or west of Cass Ave. Enter Cass Ave. at Norfolk Street, proceed to alley behind Manning lot. Additional parking is available ¼ block south behind Bank of America. *If you are only spectating, please park on a side street.*

Time & set-up: Participants may set up any time after 3:30pm. Registration will be available after 4:30pm with a participants meeting at approximately 5pm. Please, no flying until you are registered; *must show current AMA license.*

Pilots: This is an AMA Class "D" (Demo) limited event. This is not open flying. Experienced foamie, heli, multi-rotor pilots are welcome to participate. Please consult with CD first.

Flying area: The flying area is approximately 90' deep by 100' wide. This does not include the perimeter, pilot stations, and pit areas which are additional. The flying area is unobstructed.

Flying in general: *No flying over adjacent properties, sidewalk, street, etc.* Multi-rotor &/or helicopter will alternate flying time with fixed wing if necessary; to be determined on day of event. Please fly from behind pilot stations. Solo demos permitted; just ask.

Spotters: *A spotter is required for all flying.* FPV will be permitted but all FPV, no matter how small, requires a spotter.

Area lighting: The lot has HPS (orange) lighting which is sufficient when the sun goes down. LED lighting systems are not required, but would greatly enhance the demonstration in the twilight. *Note: Sunset will be at 8:20pm on July 21st; last light at 8:52pm.*

Street Fair in general: Aka "Cruisin' Nights," there are typically over 200 custom cars on display each week. The restaurants with both indoor, and outdoor, dining are open. There are activities for kids, live bands, DJs, specialty vendors & other attractions.

Come on out & enjoy the fun. It's an entertaining evening for the whole family.
